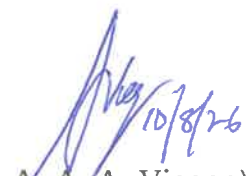

As per the UGC Circular D.O. No. F-11/2007/(CPP-II) dated 14th July 2016, column 'NOTA' – "None of the Above" option in the ballot papers will be included.

Counting of votes for the Group Representatives will take place in the same venue. However, for the Executive body, after obtaining all the ballot papers from the schools, the final counting shall be carried in the Directorate Block. The elections will be conducted strictly as per the schedule and rules. In the event of a tie during the counting of votes, a draw of lots will be done as per SSA-7.

Reference is also made to the contents of serial No. 5 under instructions to the candidates contesting for the post of Executive body, viz. President, Secretary, Sports Secretary and Cultural Secretary, Ladies Representative and Research Student's Representative. In the case of candidates contesting for the Executive body, their representative for the designated School only shall be allowed with an authority letter issued by the Director, Directorate of Students Welfare & Cultural Affairs. These representatives can also be present at the time of counting. However, such representatives shall not be permitted to visit any other School. The candidate contesting the Executive body shall provide the list of such 9 representatives to the Directorate Office latest by **24th August 2026, by 10.00 a.m.**

The elections will be conducted strictly as per the schedule and rules.
