Steps Involved in Exam Registration :-

- Online Paper Registration will begin from **25th August 2026**.

- Students have to complete the online paper registration by filling up the google form.
- Immediately after filling up the google form, students have to complete the Exam Form by payment of fees through SB Collect by **06th September 2026**.
After 06th September 2026 Late Fee of Rs 375/- will be applicable till 08th September 2026.
No Further Extension will be allowed.
- The receipt generated in SB Collect portal needs to be uploaded on google form & download the acknowledgment receipt sent to their registered email id, without which the form will be considered incomplete and form will be rejected.**
- Students have to submit the acknowledgment receipt to their School office.**

3) For Programme-Director of the School:-

- SB Collect Payment receipts, Acknowledgement receipts hard copy collected from the student & Examinations Time-Table** to be sent to the Exam PG Office by the School by **10th September 2026**.
- By **11th September 2026**, Candidate List and Admit Cards will be generated and sent to the School.
- By **11th September 2026**, Blank Marks Input Forms of ITA/TEA will be sent to the School.

IV. ITA marks (Hard copy and Soft Copy) to be submitted to the Exam PG Office by 21st September 2026.

V. TEA marks (Hard copy and Soft Copy) to be submitted to the Exam PG Office by 06th October 2026.

4) The Examinations Fees to be collected from the students will be as per university Circular No. GU/Exam Fee/20/2026/80, Dated 29/06/2026.

5) No Forms will be accepted in the examination section beyond dates mentioned.

As per the ordinance, The answer scripts shall be assessed by the teacher concerned, within ten days from the date of the examination. Before finalizing the scores obtained, the answer scripts shall be shown to the students after specifying the date and time on the Notice Board in advance.
