Goa University has decided to permit students awaiting revaluation results of the Undergraduate Programme to attend classes of Postgraduate Programmes on a provisional basis.

1. Any candidate who has applied for revaluation of the qualifying examination and the revaluation result is awaited, such student may be provisionally allowed to attend classes **only against a vacant seat** in the concerned Postgraduate Programme, subject to the candidate furnishing a written undertaking in the prescribed format attached at **Annexure I**.
2. The candidate shall have to submit an application to the respective School on Goa University Campus or its affiliated Colleges by **5th August 2026, 03:00 pm**. The application format is attached as **Annexure II**. **The respective School/affiliated Colleges shall allow them to attend the classes**. Schools/Colleges shall allow candidates only to the extent of seats available. Candidates shall be identified based on the order of GU-ART Rank.
3. In the event the candidate is not declared successful in the revaluation, the provisional approval to attend classes shall stand cancelled automatically without any further notice, and the candidate shall cease to be a student of the concerned Postgraduate Programme.
4. Seat confirmation Fees from such students shall be collected after the declaration of the revaluation result.
